# WHAT DO WFS, WCC, WFI, WPM and WESTLAKE DIRECT (collectively "US", "WE" or "OUR") DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  Social Security number and income account balances and payment & transaction history credit scores and phone numbers

Our affiliates include financial companies such as WFS, WCC, WFI, WPM, Westlake Direct, Toyota of North Hollywood, Midway Rent a Car, Knight Management Insurance Services, Knight Insurance Company, KnightBrook Insurance Company, CULA, LLC; and nonfinancial companies such as Nowcom Corporation and GlobalTrack GPS, LLC.				
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Nonaffiliates we share with can include financial companies, nonfinancial companies, autorelated companies, and marketing analytics companies.				
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners can include dealerships with whom we have a business relationship.				

### Other important information

<u>California Residents Only</u>: California residents have additional rights to limit sharing. Also, we will not disclose your personal information to nonaffiliated third parties unless you authorize us to make those disclosures.
